6.1-6.7 Superintendent's Report

Superintendent Sarah Dildine reported to the Board an enrollment of 1,125 students; 20 of the total are virtual students. TEA has determined that local school districts can end virtual schooling for students that are not passing or who are not attending the virtual instruction. If a student's grade is less than 70 or the student has been absent three or more times, the parent will receive a letter advising them that the student must attend classes in person. There are TEA approved reasons for remaining in virtual learning. Hughes Springs ISD does have lab-confirmed cases of students and staff that have Covid, but the numbers are much less than other districts in the area. Mrs. Dildine also briefed the board members on what the results of the College, Career, and Military Readiness Report would have been for this past school year.
