3.1 Certification of Unopposed Candidates for General Election of School Trustees on May 1, 2021

Secretary to Superintendent Nita Clark read for the Secretary of the Board the Certification of Unopposed Candidates for the Election on May 1, 2021, of School Trustees. Incumbents DeAnna Putman, in Place 4 and Scott Nelson, Place 5, will be declared elected and installed at the May 10, 2021, Regular School Board Meeting.

3.2 PUBLIC HEARING FOR TAPR REPORT

Curriculum Director Theresa Jennings presented an overview of the Texas Academics Performance Report for 2019-2020. The report included updated information regarding the school districts not being rated due to the Covid-19 Pandemic, district and campus performance profiles, accreditation status, performance objectives, and PEIMS financial standard reports for 2018-2019. 3.2 CONSIDERATION to Approve Budget Amendments (as needed) (HSISD Policy CE, Education Code 44.006)

There were two budget amendments; one taking money from student travel moving funds to maintenance building supplies for backpack hooks, and another moving money from the padding account to maintenance and operating supplies for vaping detection expenses.

On motion by DeAnna Putman, seconded by Robyn Shelton, it was moved to approve the consent agenda items. Motion carried on a 7 to 0 vote.

5.1 CONSIDERATION to Approve Cancellation of General Election on May 1, 2021 [HSISD Policies BBBA & BBBB; Election Code 2.053(a)(e)]

On motion by Robyn Shelton, seconded by Billy Willis, it was moved to approve the Cancellation of Election for a general election to be held on May1, 2021, to elect trustees for Places 4 and 5, currently held by DeAnna Putman and Scott Nelson. Motion carried on a 7 to 0 vote.

5.2 CONSIDERATION to Approve a Resolution Related to Winter Weather Emergency *(TEC Section 21/401(c-1); Education Code 11.151 (b)(d);HSISD Policy BAA)*

On motion by Phillip Chapman, seconded by DeAnna Putman, it was moved to approve the resolution stating that employees will not have to make up the workdays from February 16th to 19th, 2021, when school was closed due to a major snow storm that week. Motion carried on a 7 to 0 vote.

5.3 CONSIDERATION to Approve Waiver for Missed School Days

(TEC 25.081; HSISD Policy BAA; Education Code 11.151(b) (d)) On motion by Phillip Chapman, seconded by Scott Nelson, it was moved to approve asking TEA for a waiver of the four days of instruction missed during the week of the snow storm, so as to not use any built-in minutes for student instruction, in the event they may be needed later in the year.

5.4 CONSIDERATION to Approve Action for Hughes Springs ISD Regarding Executive Order GA-34 Issued by Gov. Greg Abbott and Covid-19 Update for Public Health Guidance Issued by Texas Education Agency (TGC Section 418.012; THS Code, Section 18.082 (e)

The Board discussed the options available to the District for deciding how to continue for the rest of the school year following the announcement by the Governor to remove the mandate for wearing a mask and to evaluate the Public Health Guidelines. Board members were given the results of a survey indicating what other school districts in the area were planning. On motion by Robyn Shelton, seconded by Robert Johnson, it was moved to continue requiring masks per the HSISD District Health Guidelines dated December 4, 2020, and to reevaluate the issue at the April 12, 2021, board meeting. It was also decided to send out a survey to only the parents of students for opinions or suggestions prior to April's meeting about wearing masks. Motion carried on a 7 to 0 vote

Superintendent Sarah Dildine advised the Board the enrollment on Friday was 1143, and there are currently 7 students enrolled in virtual classes, six of them in the elementary and one in high school. Once again, HSISD students have advanced to regional, state or international competitions in Power Lifting, One-act Play, and DECA. Students in Health Science have earned CNA certifications and other students have earned certifications in Microsoft. Junior high school cheerleader tryouts are this week. TEA announced that funding will not be based on attendance as it usually is, due to the Covid-19 pandemic.
