

## Board President Annual Announcement for 2022-2023 on Continuing Education of Board Members

### BASIC LEGAL REQUIREMENTS:

School board members must complete training that is required by the State Board of Education (SBOE), and the board president must publicly announce whether each board member has met their training requirements. The announcement must be made at the last regular meeting of the board before an election of trustees.

**General Content of Announcement:** The board president must announce the name of each board member who:

- Has completed the required continuing education;
- Has exceeded the required continuing education; and
- Is deficient in meeting the required continuing education.

**Continuing Education Training Areas:** Board members must receive continuing education training in eight areas, including:

1. Local District Orientation
2. Orientation to the Texas Education Code
3. Post-Legislative Update to the Texas Education Code
4. Team Building
5. Additional Continuing Education (based on the framework for governance leadership)
6. Evaluating Student Academic Performance and Setting Goals
7. Identifying and Reporting Abuse, Trafficking, and Other Maltreatment of Children
8. School Safety

*Legal Authority: Tex. Educ. Code §11.159; 19 Tex. Admin. Code § 61.1*

### Local District Orientation:

One new board member was required to complete **local district orientation** training for the time period covered by this announcement.
