The Student HireAbility Navigator program is a statewide strategy that focuses exclusively to improve and increase services to students with disabilities who are in the early phases of preparing for transition to post- secondary education and employment. (See Student HireAbility ppt)

My name is Whitney Yarber and I am the Student HireAbility Navigator for Workforce Solutions Northeast Texas. In my position, I work with high schools, employers, and community partners in 9 counties to raise awareness of resources and activities available to students with disabilities.

Within my scope of work, I also help to increase community coordination and provide information, training, and technical assistance, along with engaging employers to increase understanding and develop work-based learning opportunities. I work in conjunction with Texas Workforce Vocational Rehabilitation Services (TW-VRS) helping students with disabilities prepare for the transition from school to adult life, employment, and independence.

For students, the pre-employment transition begins long before crossing the stage in their cap and gown. The Pre-Employment Transition Services that we offer are designed as an early start to job exploration, and to assist students in making the transition from secondary to post-secondary education, training and/or competitive integrated employment. In collaboration with local education agencies and qualified community partners, Texas Workforce Vocational Rehabilitation Services (TW-VRS) will provide, or

arrange for, the provision of Pre-Employment Transition Services for students with disabilities who are in need of such services and who meet eligibility criteria.
