

# Hughes Springs Independent School District Cafeteria Charging Policy



## **What is the charging limit?**

- \$60 to \$70 is the limit allowed for charges **per account for High School.**

## **What happens when an account reaches the charging limit?**

- When an account reaches the limit, they can still get a regular lunch tray and are charged for it.
- We don't have any alternate meals.

## **Can my child still purchase "extras" if we owe money?**

- No, a student is not allowed to purchase any extras if they owe money. Examples of Extras: ice cream, extra meat, etc.

## **How often does the school send out account notices?**

- When the account reaches the \$60 to \$70 limit once a month, we will send out letters to the parents and try and get the money for the meals.
- We also send letters to the campus principal, and he will call the student in and hand them the letter to take home to their parent with a lunch form on the back of the letter.
- Parents can also view their cafeteria account online through Skyward Family Access. Call your child's campus for your username/password.
