

CHAPTER 141
SECTION 141.040**

Sec. 141.040. NOTICE OF DEADLINES.

(a) The authority with whom an application for a place on the ballot under this subchapter must be filed shall post notice of the dates of the filing period in a public place in a building in which the authority has an office not later than the 30th day before:

- (1) the first day on which a candidate may file the application; *(30th day before filing deadline)* or
- (2) the last day on which a candidate may file the application, *(78th day before election day)* if this code does not designate a first day on which the candidate may file the application.

(b) This section does not apply to an office filled at the general election for state and county officers.

| Membership | The Board shall consist of seven members. |
| Method of Election | Election of Board members shall be by position. |
| Election Date | General election of Board members shall be on the May uniform election date. <i>(first Saturday in May)</i> |
| Terms and Election Schedule | Board members shall be elected for three-year terms, with elections conducted annually, as follows: |
| Positions 4 & 5 | The election for positions 4 and 5 shall be held in 2018, 2021, 2024, and in three-year intervals thereafter. |
| Positions 6 & 7 | The election for positions 6 and 7 shall be held in 2019, 2022, 2025, and in three-year intervals thereafter. |
| Positions 1, 2, & 3 | The election for positions 1, 2, and 3 shall be held in 2020, 2023, 2026, and in three-year intervals thereafter. |
| Method of Voting | To be elected, a candidate must receive more votes than any other candidate for the position |
