\_\_\_\_\_ I will ensure my student completes asynchronous activities assigned **each day** that school is in session according to the 2020-2021 HSISD School Calendar.

\_\_\_\_\_ I will be held accountable for student attendance daily. I acknowledge that truancy will be enforced.

\_\_\_\_\_ I understand that the expectations for classwork and grading will follow district policy for on-campus instruction. Courses taken by students participating in virtual instruction will be included in calculating GPA and class rank in accordance with local policy.

\_\_\_\_\_ I understand that some elective courses may have coursework that can only reasonably be completed in person. Some courses may require a student to obtain equipment from campus in order to complete coursework virtually.

\_\_\_\_\_ I understand that it is my responsibility to maintain communication with my child's virtual teacher and to create a learning partnership.

\_\_\_\_\_ I understand that conditions surrounding the COVID-19 pandemic are continually evolving and Hughes Springs ISD's Virtual Instruction plan is subject to change based on federal, state and local guidelines.
